22 Application for Default Judgment Against Defendants Bodog Entertainment Group, S.A.;  
23 Bodog.Net; and Bodog.Com (hereinafter the "Bodog Entities"), including the affidavit and all  
24 exhibits attached thereto. Pursuant to Federal Rule of Civil Procedure 55(b)(2), the Court has  
25 determined that an evidentiary hearing is not necessary and that the information and affidavit  
26 provided by Plaintiff is sufficient to enter default in this matter. *Time Warner Cable of New York  
27 City v. Foote*, 2002 WL 1267993 (E.D.N.Y. 2002) (citing *Auction S.A. v. Marc Rich & Co.*, 951  
28 F.2d 504, 508 (2<sup>nd</sup> Cir. 1991), cert. denied, 503 U.S. 1006 (1992); *Fustok v. Conticommodity  
Services Inc.*, 873 F.2d 38, 40 (2<sup>nd</sup> Cir. 1989)).

The Court further finds that the amount of the default judgments is reasonably calculable as set forth in detail in Mr. Lewis' Affidavit and the attached documentary evidence.
