2 AN ACT TO AUTHORIZE AND REGULATE WAGERING ON PROFESSIONAL,
3 COLLEGE, AND AMATEUR SPORTS AND ON HORSE RACING IN NORTH
4 CAROLINA, AND TO AUTHORIZE LIVE HORSE RACING IN NORTH CAROLINA.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** Chapter 18C of the General Statutes is amended by adding a new
7 Article to read:

8 "Article 9.

9 "Sports Wagering.

10 "**§ 18C-901. Definitions.**

11 As used in this Article, the following definitions apply:

- 12 (1) Amateur sports. – A sporting competition that is not a professional sport,
13 college sport, or youth sport. This term includes domestic, international, and
14 Olympic sporting competitions.
- 15 (2) Cash equivalent. – An asset convertible to cash for use in connection with
16 authorized sports wagering that includes all of the following:
17 a. Foreign currency and coin.
18 b. Personal check and draft.
19 c. Digital, crypto, and virtual currency.
20 d. Online and mobile payment systems that support online money
21 transfers.
22 e. Credit card and debit card.
23 f. Prepaid access instrument.
24 g. Any other form approved by the Commission.
- 25 (3) College sports. – An athletic or sporting competition in which at least one
26 participant is a team or contestant competing on behalf of or under the
27 sponsorship of a public or private institution of postsecondary education. This
28 term shall not include a public or private institution of postsecondary
29 education sponsorship of professional sports.
- 30 (4) Covered services. – Any service creating sports wagering markets and
31 determination of sports wager outcomes that involves the operation,
32 management, or control of sports wagers authorized by this Article. The term
33 shall not include any of the following:
34 a. Payment processing and similar financial services.

- 1 b. Customer identity, age verification, and geolocation services.
2 c. Streaming or other video and data that does not include the
3 determination of odds or line information.
4 d. Telecommunications, internet service providers, and other similar
5 services not specifically designed for sports wagering.
6 e. Other goods or services not specifically designed for use in connection
7 with sports wagering.
8 (5) Electronic sports. – Leagues, competitive circuits, tournaments, or similar
9 competitions where individuals or teams play video games, typically for
10 spectators, either in person or online, for prizes, money, or entertainment.
11 (6) Geofencing. – Technology approved by the Commission and utilized by an
12 interactive sports wagering operator to verify a registered player's geolocation
13 prior to the time the registered player is placing a sports wager.
14 (7) Gross wagering revenue. – The total of amounts received by an interactive
15 sports wagering operator from sports wagers as authorized under this Article
16 less the amounts paid as winnings before any deductions for expenses, fees,
17 or taxes.
18 (8) Interactive account. – A mobile account established by a registered player for
19 the purpose of placing sports wagers in accordance with this Article.
20 (9) Interactive sports wagering operator. – The holder of an interactive sports
21 wagering license issued by the Commission.
22 (10) Key person. – An officer or director of a licensee or applicant for licensure
23 who is directly involved in the operation, management, or control of sports
24 wagering authorized under this Article, or who exercises substantial influence
25 or control over the sports wagering activities.
26 (11) Official league data. – Statistics, results, outcomes, and other data relating to
27 a sporting event obtained pursuant to an agreement with the relevant sports
28 governing body or an entity expressly authorized by the relevant sports
29 governing body to provide such data.
30 (12) Parimutuel wager. – A betting system in which all the bets of a particular type
31 are placed together in a pool and the sports wager is placed against other sports
32 wagers on the same sporting event in which the participants finish in a ranked
33 order.
34 (13) Professional sports. – An athletic or sporting competition involving at least
35 two competitors who receive compensation for participating in such event.
36 (14) Registered player. – An individual who has established an interactive account
37 with an interactive sports wagering operator.
38 (15) Service provider. – A business entity that provides covered services to an
39 interactive sports wagering operator and holds a service provider license.
40 (16) Sporting event. – Professional sports, amateur sports, and college sports, all
41 of which may include electronic sports, and any other event approved by the
42 Commission.
43 (17) Sports facility. – Any of the following:
44 a. A motorsports facility that annually hosts more than one National
45 Association for Stock Car Auto Racing national touring race.
46 b. A facility that hosts a professional golf tournament with more than
47 50,000 live spectators anticipated to attend based on similar prior
48 tournaments.
49 c. A facility that is the home location of a professional sports team that
50 competes in any of the following professional leagues:
51 1. Major League Baseball.

- 1 a. Professional sports.
2 b. Sporting events that occur under the sponsorship or oversight of
3 national or international athletic bodies that are not educational
4 institutions and that include participants both over and under the age
5 of 18.

6 **"§ 18C-902. Authorization of sports wagering generally.**

7 (a) Notwithstanding any provision of Article 37 of Chapter 14 of the General Statutes,
8 sports wagering as authorized by this Article shall not be considered unlawful. All sports
9 wagering authorized under this Article shall be placed via an interactive account or at a place of
10 public accommodation and shall be initiated and received within this State except as provided in
11 G.S. 18C-928. The interactive sports wagering operator shall comply with all of the following:

12 (1) Ensure that the registered player is located within the State, and not present
13 on Indian lands within the State, when placing any sports wager, by utilizing
14 geofencing.

15 (2) Monitor and block attempts to place unauthorized sports wagers.

16 (b) This Article does not apply to interactive sports wagering conducted exclusively on
17 Indian lands by an Indian tribe operating in accordance with a Tribal-State gaming compact and
18 authorized to conduct Class III gaming pursuant to a compact with the State. For purposes of this
19 Article, sports wagering is conducted exclusively on Indian lands only if the individual who
20 places the sports wager is physically present on Indian lands when the sports wager is initiated
21 and received by an Indian tribe operating on the same Indian lands in accordance with a
22 Tribal-State gaming compact and in conformity with the safe harbor requirements as provided in
23 31 U.S.C. § 5362(10)(c).

24 (c) An interactive sports wagering operator licensed under G.S. 18C-904 shall not, by
25 virtue of such licensure, be authorized to accept any sports wager if the registered player placing
26 the sports wager is physically present on Indian lands when the sports wager is initiated and
27 received. An interactive sports wagering operator licensed under G.S. 18C-904 shall be
28 authorized to accept a sports wager only if the registered player placing the sports wager is
29 physically present in this State when the sports wager is initiated and received. Each interactive
30 sports wagering operator licensed under G.S. 18C-904 shall use geofencing approved by the
31 Commission to ensure compliance with this Article.

32 (d) Nothing in this Article shall authorize any of the following:

33 (1) Sports wagering involving youth sports.

34 (2) Sports wagering on any of the following:

35 a. The occurrence of injuries.

36 b. The occurrence of penalties.

37 c. The outcome of disciplinary proceedings against a participant in a
38 sporting event.

39 d. The outcome of replay reviews.

40 (3) The Commission serving as an operator of a sports wagering platform.

41 (4) The placing of a parimutuel wager.

42 (e) Nothing in this Article shall apply to fantasy or simulated games or contests in which
43 one or more fantasy contest players compete and winning outcomes reflect the relative
44 knowledge and skill of the fantasy contest players and are determined predominantly by
45 accumulated statistical results of the performance of individuals, including athletes in the case of
46 sporting events.

47 (f) Upon request and with reasonable notice, the Commission or the Department of
48 Revenue has the authority to audit any interactive sports wagering operator or its service
49 providers as related to sports wagering activities.

50 (g) Any sports governing body on whose sporting events sports wagering is authorized
51 by this Article may enter into commercial agreements with interactive sports wagering operators

1 or other entities in which the sports governing body may share in the amount bet from sports
2 wagering on sporting events of the sports governing body. A sports governing body is not
3 required to obtain a license or any other approval from the Commission to lawfully accept such
4 amounts.

5 (h) Nothing in this Chapter shall authorize the Commission to establish, require, or
6 enforce a maximum or minimum payout or hold percentage upon any interactive sports wagering
7 operator.

8 (i) All of the following persons are prohibited from engaging in sports wagering:

9 (1) Any person under the age of 21.

10 (2) Any person who has requested and not revoked a voluntary exclusion
11 designation from sports wagering pursuant to G.S. 18C-922.

12 (3) Any person who has been adjudicated by law as prohibited from engaging in
13 sports wagering.

14 (4) Any member or employee of the Commission if placing a sports wager in this
15 State.

16 (5) Any employee or key person of an interactive sports wagering operator or
17 service provider license when placing sports wagers with that interactive
18 sports wagering operator.

19 (6) With respect to a sporting event, any participant in that sporting event,
20 including an athlete, coach, trainer, official, or any employee or staff of a
21 participant, when placing a sports wager on that sporting event in which that
22 participant is participating.

23 (7) Any employee or staff of a sports governing body, when placing a sports
24 wager on sporting events with which that individual or sports governing body
25 is affiliated.

26 **"§ 18C-903.** Reserved for future codification purposes.

27 **"§ 18C-904. Interactive sports wagering license.**

28 (a) It shall be unlawful for any person to offer or accept sports wagers in this State without
29 a valid interactive sports wagering license. Except as provided in G.S. 18C-928, the Commission
30 shall authorize no more than 12 interactive sports wagering operators to offer and accept sports
31 wagers on sporting events, which shall include any of the following:

32 (1) Professional sports.

33 (2) College sports.

34 (3) Electronic sports.

35 (4) Amateur sports.

36 (5) Any other event approved by the Commission in accordance with this Article.

37 (b) The Commission shall review and issue sports wagering licenses to qualified
38 applicants. The applicant shall complete and submit an application on a form prescribed by the
39 Commission and a licensing fee of one million dollars (\$1,000,000). If the application is denied,
40 the licensing fee shall be refunded, minus any expenses the Commission incurs in reviewing the
41 application.

42 (c) The application shall set forth all of the following:

43 (1) The proposed initial business plan, including the range of contemplated types
44 and modes of sports wagering.

45 (2) The proposed measures to address age and identity verification and
46 geolocation requirements.

47 (3) The proposed internal controls that will prevent ineligible persons from
48 participating in sports wagering.

49 (4) A documented history of working to prevent compulsive gambling, including
50 training programs for its employees.

- 1 (5) A written information security program detailing information security
2 governance and the designation of a chief security officer or equivalent.
- 3 (6) The proposed sports wagering brand that the applicant plans to hold out to the
4 public displaying its sports wagering platform.
- 5 (7) Any personal information the Commission may deem necessary concerning
6 the applicant's key persons.
- 7 (8) A documented history of job creation in this State and a plan for continued
8 job creation in this State.
- 9 (9) A documented history of capital investment in this State and a plan for
10 continued capital investment in this State.
- 11 (10) A documented history of partnership with a sports facility, if any, and the
12 intentions of that partnership to offer the placement of sports wagers at a place
13 of public accommodation in accordance with this Article.
- 14 (11) Any other information the Commission may deem necessary.

15 (d) The Commission shall conduct a background investigation on the applicant and key
16 persons as deemed necessary by the Commission. The background investigation shall include a
17 credit history check, a tax record check, and a criminal history record check. In the event an
18 applicant and its key persons have had a completed criminal history record check in the 12
19 months prior to the application, the Commission may, in its discretion, accept the results of that
20 prior criminal history record check upon submission of an affidavit that there has been no change
21 in criminal history since the prior criminal history record check in this or any other state. The
22 Commission shall not award a license if an applicant or any key person of the applicant has been
23 convicted of a felony or any gambling offense in any state or federal court of the United States
24 within 10 years of application or renewal.

25 (e) An applicant for licensure and any key person deemed necessary by the Commission
26 shall consent to a criminal history record check and shall submit all necessary fingerprints.
27 Refusal to consent to a criminal history record check may constitute grounds for the Commission
28 to deny licensure.

29 (f) The Commission shall grant or deny all applications under this section. The grounds
30 for denial of an interactive sports wagering license shall be the same as in G.S. 18C-906(g). If
31 there are more qualified applicants than the number of interactive sports wagering operators
32 authorized under subsection (a) of this section, the Commission shall select the best qualified
33 applicants, taking into consideration the following factors:

- 34 (1) The contents of the application submitted in accordance with this section.
- 35 (2) The extent to which the applicant demonstrates past experience, financial
36 viability, compliance with applicable laws and regulations in other
37 jurisdictions, and success with sports wagering operations in other
38 jurisdictions.
- 39 (3) The extent to which the applicant is able to meet the duties of an interactive
40 sports wagering operator.
- 41 (4) The amount of gross wagering revenue and associated tax revenue that an
42 applicant is projected to generate.
- 43 (5) The extent to which the applicant, or an affiliate of the applicant, will create
44 jobs in conjunction with sports wagering in this State.
- 45 (6) The extent to which the applicant, or an affiliate of the applicant, has made
46 capital investments in this State, and the timing of such capital investments.
- 47 (7) The extent to which the applicant, or an affiliate of the applicant, has a plan to
48 open and operate a place of public accommodation in accordance with this
49 Article.
- 50 (8) Any other factors the Commission deems relevant.

1 (g) A person holding a license to conduct sports wagering, on the basis of comparable
2 licensing requirements issued to that person by a proper authority in another state or territory of
3 the United States or the District of Columbia if that jurisdiction's requirements for licensure,
4 certification, or registration are substantially equivalent to or exceed the requirements of this
5 State, and who, in the opinion of the Commission otherwise meets the requirements of this Article
6 based upon verified evidence may, upon application, be licensed as an interactive sports wagering
7 operator with or without further examination, as determined by the Commission. The
8 Commission may also accept another jurisdiction's or approved third party's testing of the
9 interactive sports wagering platform as evidence that the sports wagering platform meets any
10 requirements mandated by the Commission.

11 (h) The Commission shall review and issue interactive sports wagering licenses to
12 qualified applicants within 60 days of receipt of a completed application. The Commission may
13 extend the review period for an additional 30 days if the background investigation is outstanding.
14 Any denial shall be in writing and state the grounds therefor.

15 (i) Notwithstanding Chapter 132 of the General Statutes or any other provision of law,
16 only the following documents under this section shall be a public record, with respect to each
17 applicant and each interactive sports wagering operator:

18 (1) The name, address, and sports wagering platform.

19 (2) The names of all key persons.

20 (3) The documented history of working to prevent compulsive gambling,
21 including training programs for its employees.

22 (4) The proposed sports wagering brand that the applicant plans to hold out to the
23 public displaying its sports wagering platform.

24 (5) The granting or denial of the application.

25 (j) Each interactive sports wagering operator shall promptly report all criminal or
26 disciplinary proceedings commenced against that interactive sports wagering operator in
27 connection with its operations to the Commission. Each interactive sports wagering operator shall
28 promptly report to the Commission all changes in key persons, and all new key persons shall
29 consent to a background investigation.

30 (k) No interactive sports wagering operator license is assignable or transferable without
31 approval of the Commission.

32 (l) Interactive sports wagering operators shall assure the financial integrity of sports
33 wagering operations by the maintenance of a reserve of not less than five hundred thousand
34 dollars (\$500,000) or the amount required to cover the outstanding liabilities for sports wagers
35 accepted by the interactive sports wagering operator, whichever is greater. The reserve may take
36 the form of a bond, an irrevocable letter of credit, payment processor reserves and receivables,
37 cash or cash equivalents segregated from operational funds, guaranty letter, a combination
38 thereof, or any other means as approved by the Commission. Such reserve shall be adequate to
39 pay winning sports wagers when due. An interactive sports wagering operator is presumed to
40 have met this requirement if the operator maintains, on a daily basis, a minimum reserve in an
41 amount which is at least equal to the average daily minimum reserve, calculated on a monthly
42 basis, for the corresponding month in the previous year. For purposes of this subsection,
43 "outstanding liabilities for sports wagers accepted by an interactive sports wagering operator"
44 shall mean the amounts accepted by the interactive sports wagering operator on sports wagers
45 whose outcomes have not been determined and amounts owed but unpaid on winning sports
46 wagers.

47 "§ 18C-905. Reserved for future codification purposes.

48 "§ 18C-906. Applications for service provider licenses.

49 (a) It shall be unlawful for any person to provide covered services to any interactive
50 sports wagering operator in this State without a valid service provider license. An interactive

1 sports wagering operator who provides covered services in-house shall not be required to have a
2 service provider license in addition to the interactive sports wagering operator license.

3 (b) The Commission shall review and issue service provider licenses to qualified
4 applicants within 60 days of receipt of a completed application. The Commission may extend the
5 review period for an additional 30 days if the background investigation is outstanding. Any denial
6 shall be in writing and state the grounds therefor. The applicant shall submit the completed
7 application, on a form prescribed by the Commission, and the licensing fee of fifty thousand
8 dollars (\$50,000).

9 (c) The application shall set forth all of the following:

10 (1) The applicant's background in sports wagering or the covered service.

11 (2) All experience with sports wagering or other wagering activities in other
12 jurisdictions, including the applicant's history, reputation of integrity and
13 compliance, and a list of all active and inactive licenses, certifications, or
14 registrations and reasons for inactivity, if applicable.

15 (3) A written information security program, detailing information security
16 governance and the designation of a chief security officer or equivalent.

17 (4) Any personal information the Commission may deem necessary concerning
18 the applicant's key persons.

19 (5) Any other information the Commission may deem necessary.

20 (d) The Commission shall conduct a background investigation on the applicant and key
21 persons as deemed necessary by the Commission. The background investigation shall include a
22 credit history check, a tax record check, and a criminal history record check. In the event an
23 applicant and its key persons have had a completed criminal history record check in the 12
24 months prior to the application, the Commission may, in its discretion, accept the results of that
25 prior criminal history record check upon submission of an affidavit that there has been no change
26 in criminal history since the prior criminal history record check in this or any other state. The
27 Commission shall not award a license if the applicant or any key person of the applicant has been
28 convicted of a felony or any gambling offense in any state or federal court of the United States
29 within 10 years of application or renewal.

30 (e) An applicant for licensure and any key person deemed necessary by the Commission
31 shall consent to a criminal history record check and shall submit all necessary fingerprints.
32 Refusal to consent to a criminal history record check may constitute grounds for the Commission
33 to deny licensure.

34 (f) A person holding a service provider license or its equivalent, on the basis of
35 comparable licensing requirements issued to that person by a proper authority by another state or
36 territory of the United States or the District of Columbia if that jurisdiction's requirements for
37 licensure, certification, or registration are substantially equivalent to or exceed the requirements
38 of this State, and who, in the opinion of the Commission otherwise meets the requirements of
39 this Article based upon verified evidence may, upon application, be licensed as a service provider
40 with or without further examination, as determined by the Commission.

41 (g) Grounds for denial of a license may include the following:

42 (1) The applicant is unable to satisfy the requirements under this Article.

43 (2) The applicant or any key person is not of good character, honesty, or integrity.

44 (3) The applicant's or any key person's prior activities, criminal record, reputation,
45 or associations indicate any of the following:

46 a. A potential threat to the public interest.

47 b. The potential to impede the regulation of sports wagering.

48 c. The potential of promoting unfair or illegal activities in the conduct of
49 sports wagering.

- 1 (4) The applicant or any key person knowingly makes a false statement of
2 material fact or deliberately fails to disclose information requested by the
3 Commission.
- 4 (5) The applicant or any key person knowingly fails to comply with the provisions
5 of this Article or any requirements of the Commission.
- 6 (6) The applicant or any key person was convicted of a felony, a crime of moral
7 turpitude, or any criminal offense involving dishonesty or breach of trust
8 within the 10 years prior to the submission date of the application.
- 9 (7) Any revocation, suspension, or denial of the applicant's or key person's
10 license, certification, or registration to conduct sports wagering, other forms
11 of gambling activity, or a covered service issued by any other jurisdiction.
- 12 (8) The applicant has defaulted on any obligation or debt owed to this State.
- 13 (h) Notwithstanding any other provision of law, only the following documents under this
14 section shall be a public record, with respect to each applicant and each service provider:
- 15 (1) The name, address, and sports wagering platform.
- 16 (2) The name of all key persons.
- 17 (3) The granting or denial of the application.
- 18 (i) Each service provider shall promptly report all criminal or disciplinary proceedings
19 commenced against that service provider in connection with its operations to the Commission.
20 Each service provider shall promptly report all changes in key persons to the Commission, and
21 all new key persons shall consent to a background investigation.
- 22 (j) No service provider license is assignable or transferable without approval of the
23 Commission.
- 24 **§ 18C-907. Sports wagering supplier license.**
- 25 (a) The Commission may issue a sports wagering supplier license to a sports wagering
26 supplier. An interactive sports wagering operator who provides covered services in-house shall
27 not be required to have a sports wagering supplier license in addition to the interactive sports
28 wagering operator license.
- 29 (b) At the request of an applicant for a sports wagering supplier license, the Commission
30 may issue a provisional sports wagering supplier license to the applicant so long as the applicant
31 has submitted a completed application in accordance with this section. A provisional license
32 issued under this subsection expires on the date provided by the Commission.
- 33 (c) A person may apply to the Commission for a sports wagering supplier license as
34 provided in this Article.
- 35 (d) The applicant shall complete and submit an application on a form prescribed by the
36 Commission and a licensing fee of thirty thousand dollars (\$30,000). In the application, the
37 Commission shall require applicants to disclose the identity of each of the following:
- 38 (1) The applicant's principal owners who directly own ten percent (10%) or more
39 of the applicant.
- 40 (2) Each holding, intermediary, or parent company that directly owns fifteen
41 percent (15%) or more of the applicant.
- 42 (3) The applicant's board appointed CEO and CFO, or the equivalent as
43 determined by the Commission.
- 44 (4) Any other information the Commission may deem necessary.
- 45 (e) The Commission shall conduct a background investigation on the applicant, key
46 persons of the applicant, and current employees of the applicant, as deemed necessary by the
47 Commission. The background investigation shall include a credit history check, a tax record
48 check, and a criminal history record check. In the event an applicant and its key persons have
49 had a completed criminal history record check in the 12 months prior to the application, the
50 Commission may, in its discretion, accept the results of that prior criminal history record check
51 upon submission of an affidavit that there has been no change in criminal history since the prior

1 criminal history record check in this or any other state. The Commission may not award a license
2 if the applicant or a key person of the applicant has been convicted of a felony or any gambling
3 offense in any state or federal court of the United States within 10 years of application or renewal.

4 (f) An applicant for licensure and any key person deemed necessary by the Commission
5 shall consent to a criminal history record check and shall submit all necessary fingerprints.
6 Refusal to consent to a criminal history record check may constitute grounds for the Commission
7 to deny licensure.

8 (g) The Commission shall review and issue licenses to qualified applicants within 60 days
9 of receipt of a completed application. The Commission may extend the review period for an
10 additional 30 days if the background investigation is outstanding.

11 (h) In disclosing the principal owners of the applicant, the following shall apply:

12 (1) Governmental created entities, including statutory authorized pension
13 investment boards and Canadian Crown corporations, that are direct or
14 indirect shareholders of an applicant shall be waived in the applicant's
15 disclosure of ownership and control as determined by the Commission.

16 (2) Investment funds or entities registered with the Securities and Exchange
17 Commission, including Investment Advisors and entities under the
18 management of the Securities and Exchange Commission, that are direct or
19 indirect shareholders of the applicant shall be waived in the applicant's
20 disclosure of ownership and control as determined by the Commission.

21 (i) A sports wagering supplier license or a provisional sports wagering supplier license
22 shall be sufficient to offer the sports wagering services under this Article.

23 (j) A person holding a sports wagering supplier license or its equivalent, on the basis of
24 comparable licensing requirements issued to that person by a proper authority by another state or
25 territory of the United States or the District of Columbia if that jurisdiction's requirements for
26 licensure, certification, or registration are substantially equivalent to or exceed the requirements
27 of this State, and who, in the opinion of the Commission otherwise meets the requirements of
28 this Article based upon verified evidence may, upon application, be licensed as a sports wagering
29 supplier with or without further examination, as determined by the Commission.

30 (k) Each sports wagering supplier shall promptly report all criminal or disciplinary
31 proceedings commenced against that sports wagering supplier in connection with its operations
32 to the Commission. Each sports wagering supplier shall promptly report to the Commission all
33 changes in key persons, and all new key persons shall consent to a background investigation.

34 (l) Notwithstanding any other provision of law, only the following documents under this
35 section shall be a public record, with respect to each applicant and each sports wagering supplier:

36 (1) The name, address, and sports wagering platform.

37 (2) The name of all key persons.

38 (3) The granting or denial of the application.

39 (m) No sports wagering supplier license is assignable or transferable without approval of
40 the Commission.

41 **§ 18C-908. Renewals of licenses.**

42 (a) Any license issued pursuant to this Article shall be valid for five years.

43 (b) At least 60 days prior to the expiration of a license, the license holder shall submit a
44 renewal application, on a form prescribed by the Commission, including a renewal fee as follows:

45 (1) One million dollars (\$1,000,000) for an interactive sports wagering license.

46 (2) Fifty thousand dollars (\$50,000) for a service provider license.

47 (3) Thirty thousand dollars (\$30,000) for a sports wagering supplier license.

48 (c) The Commission may revoke or deny a license renewal for any of the following
49 reasons:

50 (1) The same grounds that would constitute denial of an initial application under
51 G.S. 18C-906(g).

1 (2) A violation of this Article.

2 (3) Failure to pay the tax imposed under Article 2E of Chapter 105 of the General
3 Statutes.

4 (d) With respect to interactive sports wagering operators, the Commission may deny a
5 license renewal if the Commission finds good cause that the licensee has materially not complied
6 with the provisions of this Article.

7 **"§ 18C-909. Use of proceeds.**

8 (a) The Commission shall use the funds remitted to it pursuant to G.S. 105-113.128 and
9 any proceeds from license fees collected under this Article to cover expenses in administering
10 this Article. Any proceeds remaining at the end of each fiscal year after payment of expenses of
11 the Commission pursuant to this section shall be remitted to the General Fund.

12 (b) Expenses of the Commission shall include all items listed in G.S. 18C-163.

13 **"§ 18C-910. Duties of licensees.**

14 (a) The interactive sports wagering operator and its service providers shall make
15 commercially reasonable efforts to do all of the following:

16 (1) Prevent persons who are not registered players from placing sports wagers
17 through its sports wagering platform.

18 (2) Prevent persons who are not physically located in the State from placing a
19 wager through its sports wagering platform.

20 (3) Protect the confidential information of registered players using its sports
21 wagering platform.

22 (4) Prevent sports wagering on prohibited events set forth in this Article or as
23 otherwise determined by the Commission.

24 (5) Prevent persons from placing sports wagers as agents or proxies for others.

25 (6) Allow persons to voluntarily exclude themselves under G.S. 18C-922 from
26 placing sports wagers through its sports wagering platform as set forth in this
27 Article.

28 (7) Establish procedures to detect suspicious or illegal sports wagering activity.

29 (8) Provide for the reporting of income tax on winnings where required by
30 applicable State or federal law.

31 (9) Prevent a participant in a sporting event, including an athlete, coach, trainer,
32 official, or any employee or staff of a participant from placing a sports wager
33 on that sporting event in which the participant is participating.

34 (10) Verify the location of the sports wagerer at the time the sports wager is
35 initiated and received for compliance with G.S. 18C-902(c).

36 (b) For three years after a sporting event occurs, interactive sports wagering operators
37 shall maintain records on all of the following:

38 (1) Each sports wager, including the identity of the individual placing the sports
39 wager.

40 (2) The amount, type, time, location, and outcome of the sports wager, including
41 the IP address, if available.

42 (3) Suspicious or illegal sports wagering activity.

43 (c) The interactive sports wagering operator shall disclose the records described in
44 subsection (b) of this section to the Commission upon request.

45 (d) If a sports governing body has notified the Commission that real-time information
46 sharing for sports wagers placed on its sporting events is necessary, interactive sports wagering
47 operators shall share with that sports governing body or its designee in real time, at the account
48 level, anonymized information regarding a registered player, amount and type of sports wager,
49 the time the sports wager was placed, the location of the registered player at the time the sports
50 wager was placed, the IP address if applicable, the outcome of the sports wager, and records of
51 abnormal sports wagering activity. For purposes of this subsection, real time means on a

1 commercially reasonable periodic interval, but in any event, not less than once every 72 hours.
2 A sports governing body receiving any information pursuant to this subsection shall use the
3 information for the purpose of integrity monitoring only and not for any commercial purpose.

4 (e) In advertising its sports wagering platform, the interactive sports wagering operator
5 shall ensure that its advertisements meet all of the following requirements:

6 (1) It does not target persons under the age of 21.

7 (2) It discloses the identity of the interactive sports wagering operator.

8 (3) It provides information about or links to resources related to gambling
9 addiction and prevention.

10 (4) It is not misleading to a reasonable person.

11 (f) Background investigations shall search for criminal history and any charges or
12 convictions involving corruption or manipulation of sporting events and association with
13 organized crime.

14 (g) Interactive sports wagering operators and service providers shall employ
15 commercially reasonable methods to maintain the security of wagering data, registered player
16 and other customer data, and any other confidential information, including information provided
17 by a sports governing body, from unauthorized access and dissemination. All servers necessary
18 to the placement or resolution of a sports wager, other than back-up servers, shall be physically
19 located in this State. Consistent with federal law, nothing in this section shall preclude the use of
20 internet or cloud-based hosting, or the use of back-up servers located outside of this State.

21 (h) Each interactive sports wagering operator shall provide a daily summary of all sports
22 wagering activity, detailing all transactions processed through each wagering system, provided
23 in a format established by the Commission, at the close of each business day.

24 "**§ 18C-911.** Reserved for future codification purposes.

25 "**§ 18C-912. Establishment of interactive accounts.**

26 (a) Only a registered player shall be permitted to establish an interactive account with an
27 interactive sports wagering operator. The interactive sports wagering operator is responsible for
28 verifying the identity of the registered player and ensuring that the registered player is at least 21
29 years of age. The registered player shall be permitted to deposit cash or cash equivalents into the
30 interactive account.

31 (b) A registered player may not have more than one interactive account with each
32 interactive sports wagering operator.

33 (c) An interactive account shall meet all of the following requirements:

34 (1) Be registered in the name of the registered player, who is a natural person.

35 (2) Be established through the interactive sports wagering operator's sports
36 wagering platform.

37 (3) Be funded with cash or cash equivalents online or placed at a sports facility as
38 provided in G.S. 18C-926.

39 (4) Prohibit the transfer or sale of an account or account balance.

40 (5) Prohibit the use of any virtual private network or other technology that may
41 obscure or falsify the registered player's physical location.

42 (6) Prohibit any form of collusion, cheating, or other unlawful activity.

43 (7) Affirm that the registered player meets all eligibility requirements for
44 registration.

45 (8) Authorize the provision of notices and other required communications either
46 through a designated mobile or other interface or to an electronic mail address
47 designated by the registered player.

48 (d) The interactive sports wagering operator shall put in place sufficient measures to
49 verify the age and identity of the registered player needed to allow the establishment of
50 interactive accounts remotely.

1 (e) An interactive account held by a registered player in this State may be suspended or
2 terminated by the interactive sports wagering operator under any of the following conditions:

3 (1) The registered player has provided any false or misleading information in
4 connection with the opening of the account, or has engaged in collusion,
5 cheating, or other unlawful conduct.

6 (2) The registered player is barred from placing sports wagers in the State.

7 (3) The registered player is or otherwise becomes ineligible pursuant to this
8 Article.

9 (4) For any other reason at the sole discretion of the interactive sports wagering
10 operator, provided it is not in violation of federal or State law.

11 (f) In the event of termination of the interactive account in accordance with this section,
12 the registered player shall be provided timely ability to access and withdraw any funds remaining
13 in the interactive account.

14 "§ 18C-913. Reserved for future codification purposes.

15 "§ 18C-914. Integrity of competition and prohibited events.

16 (a) A sports governing body may submit to the Commission in writing a request to
17 restrict, limit, or exclude a certain type, form, or category of sports wagering with respect to
18 sporting events of such body, if the sports governing body believes that such type, form, or
19 category of sports wagering with respect to sporting events of such body may undermine the
20 integrity or perceived integrity of such body or sporting events of such body. The Commission
21 shall request comment from interactive sports wagering operators on all such requests. After
22 giving due consideration to all comments received, the Commission shall, upon a demonstration
23 of good cause from the requestor that such type, form, or category of sports wagering is likely to
24 undermine the integrity or perceived integrity of such body or sporting events of such body, grant
25 the request. The Commission shall respond to a request concerning a particular event before the
26 start of the event, or if it is not feasible to respond before the start of the event, no later than seven
27 days after the request is made. If the Commission determines that the requestor is more likely
28 than not to prevail in successfully demonstrating good cause for its request, the Commission may
29 provisionally grant the request of the sports governing body until the Commission makes a final
30 determination as to whether the requestor has demonstrated good cause. Absent such a
31 provisional grant by the Commission, sports wagering operators may continue to offer sports
32 wagering on sporting events that are the subject of such a request during the pendency of the
33 Commission's consideration of the applicable request.

34 (b) The Commission and interactive sports wagering operators shall cooperate with
35 investigations conducted by sports governing bodies or law enforcement agencies, including
36 using commercially reasonable efforts to provide or facilitate the provision of sports wagering
37 information. All disclosures under this section are subject to an interactive sports wagering
38 operator's obligations to comply with all federal, State, and local laws and regulations, including
39 those relating to privacy and personally identifiable information.

40 (c) Interactive sports wagering operators are not required to use official league data for
41 determining any of the following:

42 (1) The results of tier one sports wagers on sporting events of any organization
43 whether headquartered in the United States or elsewhere.

44 (2) The results of tier two sports wagers on sporting events of organizations that
45 are not headquartered in the United States.

46 (d) A sports governing body may notify the Commission that it desires interactive sports
47 wagering operators to use official league data to settle tier two sports wagers on sporting events
48 of such sports governing body. Notification shall be made in the form and manner as the
49 Commission may require. The Commission shall notify each interactive sports wagering operator
50 of a sports governing body's notification within five days of the Commission's receipt of the
51 notification. If a sports governing body does not so notify the Commission, an interactive sports

1 wagering operator is not required to use official league data for determining the results of tier
2 two sports wagers on sporting events of that sports governing body.

3 (e) Within 60 days of the Commission notifying each interactive sports wagering
4 operator of a sports governing body notification to the Commission, or longer period as may be
5 agreed between the sports governing body and the applicable interactive sports wagering
6 operator, interactive sports wagering operators shall use only official league data to determine
7 the results of tier two sports wagers on sporting events of that sports governing body, unless any
8 of the following apply:

9 (1) The sports governing body or its designee cannot provide a feed of official
10 league data to determine the results of a particular type of tier two sports
11 wager, in which case interactive sports wagering operators are not required to
12 use official league data for determining the results of the applicable tier two
13 sports wager until such time as such a data feed becomes available from the
14 sports governing body on commercially reasonable terms and conditions.

15 (2) An interactive sports wagering operator can demonstrate to the Commission
16 that the sports governing body or its designee will not provide a feed of official
17 league data to the interactive sports wagering operator on commercially
18 reasonable terms and conditions.

19 (3) The designee of the sports governing body does not obtain a sports wagering
20 supplier license from the Commission to provide official league data to
21 interactive sports wagering operators to determine the results of tier two sports
22 wagers, if and to the extent required by law.

23 (f) During the pendency of the Commission's determination as to whether a sports
24 governing body or its designee will provide a feed of official league data on commercially
25 reasonable terms, an interactive sports wagering operator is not required to use official league
26 data for determining the results of tier two sports wagers. The Commission's determination shall
27 be made within 60 days of the interactive sports wagering operator notifying the Commission
28 that it desires to demonstrate that the sports governing body or its designees will not provide a
29 feed of official league data to the sports wagering operator on commercially reasonable terms.
30 The following is a non-exclusive list of factors the Commission may consider in evaluating
31 whether official league data is being offered on commercially reasonable terms and conditions
32 for purposes of this subsection and subsections (d) and (e) of this section:

33 (1) The extent to which interactive sports wagering operators have purchased the
34 same or similar official league data on the same or similar terms, particularly
35 in jurisdictions where such purchase was not required by law, or was required
36 by law, but only if offered on commercially reasonable terms.

37 (2) The nature and quantity of the official league data, including its speed,
38 accuracy, reliability, and overall quality, as compared to comparable
39 non-official data.

40 (3) The quality and complexity of the process used to collect and distribute the
41 official league data as compared to comparable non-official data.

42 (4) The availability of a sports governing body's tier two official league data to an
43 interactive sports wagering operator from more than one authorized source.

44 (5) Market information, including price and other terms and conditions, regarding
45 the purchase by interactive sports wagering operators of comparable data for
46 the purpose of settling sports wagers in this State and other jurisdictions.

47 (6) The extent to which sports governing bodies or their designees have made data
48 used to settle tier two sports wagers available to interactive sports wagering
49 operators and any terms and conditions relating to the use of that data.

50 (7) Any other information the Commission deems relevant.

1 (g) Interactive sports wagering operators shall, as soon as practicable, report to the
2 Commission any information relating to abnormal betting activity or patterns that may indicate
3 a concern with the integrity of a sporting event or events, or any other conduct that corrupts a
4 sports wagering outcome of a sporting event or events for purposes of financial gain, including
5 match fixing. The interactive sports wagering operator making such a report shall also
6 simultaneously report such information to the relevant sports governing body.

7 **"§ 18C-915.** Reserved for future codification purposes.

8 **"§ 18C-916. Civil penalties; suspension and revocation of licenses.**

9 If the Commission determines that the holder of a license under this Article has violated any
10 provision of this Article, the Commission, with at least 15 days' notice and a hearing, may do
11 either or both of the following:

12 (1) Suspend or revoke the license.

13 (2) Impose a monetary penalty of not more than ten thousand dollars (\$10,000)
14 for each violation.

15 **"§ 18C-917.** Reserved for future codification purposes.

16 **"§ 18C-918. Criminal penalties.**

17 (a) Any person who knowingly offers or engages in sports wagering in violation of this
18 Article shall be guilty of a Class 2 misdemeanor.

19 (b) Any person under the age of 21 who engages in sports wagering as defined under this
20 Article shall be guilty of a Class 2 misdemeanor.

21 (c) Any person who knowingly attempts to suborn, collude, or otherwise conspire to
22 influence the outcome of any competition or aspect of any competition that is the subject of sports
23 wagering pursuant to this Article shall be guilty of a Class G felony.

24 (d) Any applicant for an interactive sports wagering license, a service provider license,
25 or sports wagering supplier license who willfully furnishes, supplies, or otherwise gives false
26 information on the license application shall be guilty of a Class I felony.

27 (e) Nothing in this Article shall be construed to allow the interactive sports wagering
28 operator or its service providers to be charged with a violation of subsection (a) or (c) of this
29 section absent actual notice and knowledge that a person is under age or giving false information.

30 **"§ 18C-919.** Reserved for future codification purposes.

31 **"§ 18C-920.** Reserved for future codification purposes.

32 **"§ 18C-921.** Reserved for future codification purposes.

33 **"§ 18C-922. Voluntary exclusion program.**

34 (a) The Commission shall establish a voluntary exclusion program for any individual to
35 voluntarily exclude themselves from placing sports wagers under this Article and pari-mutuel
36 wagers under Article 10 of this Chapter. Interactive sports wagering operators shall use
37 reasonable means to comply with the exclusion of individuals participating in the voluntary
38 exclusion program by the Commission.

39 (b) The Commission shall adopt rules to establish the voluntary exclusion program,
40 which shall provide for all of the following:

41 (1) Verification of the individual's request to be placed in the voluntary exclusion
42 program, and for how long, up to and including that individual's lifetime.

43 (2) How information regarding which individuals are in the voluntary exclusion
44 program is to be disseminated to the interactive sports wagering operators.

45 (3) How an individual in the voluntary exclusion program may petition the
46 Commission for removal from the voluntary exclusion program.

47 (4) The means by which the interactive sports wagering operators and their agents
48 shall make all reasonable efforts to cease direct marketing efforts to
49 individuals participating in the voluntary exclusion program.

50 (5) The means by which the Commission shall make available to all interactive
51 sports wagering operators and their agents the names of the individuals

1 participating in the voluntary exclusion program, which shall be at least
2 quarterly.

3 (c) Participation in the voluntary exclusion program shall not preclude an interactive
4 sports wagering operator and its agents from seeking the payment of a debt accrued by the
5 individual while not participating in the voluntary exclusion program.

6 (d) The voluntary exclusion program shall be exempt from Chapter 132 of the General
7 Statutes and shall be treated as confidential by each interactive sports wagering operator. An
8 interactive sports wagering operator conducting sports wagering in another state may share the
9 information provided under this section with its agents and affiliates in other states for excluding
10 individuals participating in the voluntary exclusion program.

11 "§ 18C-923. Reserved for future codification purposes.

12 "§ 18C-924. Risk management.

13 The Commission shall adopt rules permitting, but not requiring, interactive sports wagering
14 operators and their service providers to employ systems that offset loss or manage or lay off risk
15 in the operation of sports wagering pursuant to this Article, including through liquidity pools,
16 exchanges, or similar mechanisms in another approved jurisdiction in which the interactive sports
17 wagering operator, service provider, or an affiliate of either or other third party also holds a
18 license or the equivalent, provided that at all times adequate protections are maintained to ensure
19 sufficient funds are available to pay all winnings.

20 "§ 18C-925. Reserved for future codification purposes.

21 "§ 18C-926. Places of public accommodation.

22 (a) Permanent places of public accommodation for the purpose of placing sports wagers
23 may be associated with each sports facility.

24 (b) Permanent places of public accommodation permitted under this section shall be
25 located as follows:

26 (1) On the property of the sports facility.

27 (2) No more than one place of public accommodation may be on other property
28 owned or controlled by the owner or operator of the sports facility or an
29 affiliated entity of the owner or operator of the sports facility that is located
30 within a one-half mile radius of a sports facility as defined in
31 G.S. 18C-901(17)a. or G.S. 18C-901(17)c.

32 (3) No more than one place of public accommodation may be on other property
33 owned or controlled by the owner or operator of the sports facility that is
34 located within a one and one-half mile radius of a sports facility as defined in
35 G.S. 18C-901(17)b.

36 (c) Nothing in this section shall be construed to exempt a place of public accommodation
37 from the provisions of any other law that may be enforceable.

38 (d) Mobile devices, computer terminals, similar devices, and cashiers used to operate the
39 place of public accommodation shall have the ability to accept cash and cash equivalents and to
40 distribute cash or cash equivalents. Only a cashier may distribute cash or cash equivalents at a
41 place of public accommodation. All cashiers that accept or distribute cash or cash equivalents
42 shall be employees of an interactive sports wagering operator.

43 (e) A place of public accommodation under this section may be advertised by the owner
44 or operator of the sports facility.

45 (f) Notwithstanding subsections (a) through (c) of this section, if a permanent place of
46 public accommodation is not located at the sports facility as defined in G.S. 18C-901(17)b. that
47 hosts the professional golf tournament, no more than one temporary place of public
48 accommodation may be established at the sports facility as defined in G.S. 18C-901(17)b. during
49 the professional golf tournament. The temporary place of public accommodation need not
50 comply with local ordinances under Chapter 160D of the General Statutes. For purposes of this
51 subsection, "temporary" shall mean opening no more than five calendar days prior to the

1 professional golf tournament and closing no later than five calendar days after the professional
2 golf tournament.

3 (g) Notwithstanding any other provision of this section, no sports facility shall be open
4 for placing sports wagers during the eight hours before or during any college sports events at the
5 sports facility or adjacent to the sports facility.

6 (h) The Commission may adopt rules as necessary governing the placement of any place
7 of public accommodation on the property of a sports facility.

8 "**§ 18C-927.** Reserved for future codification purposes.

9 "**§ 18C-928. Compliance with federal law; Indian gaming.**

10 (a) Consistent with the intent of the United States Congress as articulated in the Unlawful
11 Internet Gambling Enforcement Act of 2006 (31 U.S.C. § 5361 et seq.), the intermediate routing
12 of electronic data relating to intrastate sports wagering authorized under this Article shall not
13 determine the location or locations in which such sports wagers are initiated and received.

14 (b) All activities authorized by this Article shall be deemed to be conducted solely under
15 the authority of this Article and not under the federal Indian Gaming Regulatory Act, 25 U.S.C.
16 § 2701 et seq.

17 (c) A tribal gaming enterprise shall be deemed a licensed interactive sports wagering
18 operator upon the occurrence of all of the following:

19 (1) Submission of a completed application to the Commission.

20 (2) Agreement by the tribal gaming enterprise, in a form as prescribed by the
21 Commission, to all of the following:

22 a. Adherence to the requirements of this Article and to the regulations
23 adopted by the Commission with respect to sports wagering.

24 b. Submission to the Commission's enforcement of this Article and any
25 implementation of the rules, including waiver of any applicable tribal
26 sovereign immunity for the sole and limited purpose of such
27 enforcement.

28 c. Collection and payment of all taxes imposed under Article 2E of
29 Chapter 105 of the General Statutes.

30 d. Not offering or conducting any interactive gambling other than the
31 interactive sports wagering authorized by this Article unless
32 specifically otherwise authorized by law.

33 e. Location of any server or other information technology equipment
34 directly related to the placing of sports wagers that is used by the tribal
35 gaming enterprise and its agents to accept interactive sports wagering
36 authorized by this Article on land that is not Indian lands. Upon
37 request, make accessible any server or other information technology
38 equipment directly related to the placing of sports wagers by the
39 Commission, the Department of Revenue, and State law enforcement.
40 The location of all other technology and servers used by a tribal
41 gaming enterprise in connection with sports wagering authorized by
42 this act shall be approved by the Commission.

43 (d) Any federally recognized tribe, or business entity owned or controlled by the tribe,
44 that is deemed an interactive sports wagering operator under this Article shall include
45 authorization for any technology and sports wagering brand partners of the tribe or the business
46 entity owned or controlled by the tribe, subject to compliance with the terms of this Article by
47 the technology and sports wagering brand partners. A tribal gaming enterprise deemed an
48 interactive sports wagering operator under this section shall not count toward the total number of
49 authorized interactive sports wagering operators in this State in accordance with G.S. 18C-904."

50 **SECTION 2.** Article 10 of Chapter 143B of the General Statutes is amended by
51 adding a new Part to read:

1 "Part 2L. North Carolina Major Events, Games, and Attractions Fund.

2 **"§ 143B-437.110. Legislative findings and purpose.**

3 The General Assembly finds that:

- 4 (1) It is the policy of the State of North Carolina to stimulate economic activity
5 and to create new jobs for the citizens of the State by encouraging and
6 promoting the attraction of major events to the State that spur economic
7 activity by attracting out-of-state visitors to the State and thereby promoting
8 the travel and tourism industries within the State.
- 9 (2) The purpose of this Part is to stimulate economic activity and to create new
10 jobs within the State.
- 11 (3) The enactment of this Part will maintain consistency and accountability in a
12 key economic development program and will ensure that the program benefits
13 the State and its citizens.
- 14 (4) Nothing in this Part shall be construed to constitute a guarantee or assumption
15 by the State of any debt of any business or to authorize the taxing power or
16 the full faith and credit of the State to be pledged.

17 **"§ 143B-437.111. Definitions.**

18 The following definitions apply in this Part:

- 19 (1) Fund. – The North Carolina Major Events, Games, and Attractions Fund
20 established under G.S. 143B-437.112.
- 21 (2) Local entity. – A city, county, or local organizing committee.
- 22 (3) Local organizing committee. – A nonprofit corporation or its successor in
23 interest that satisfies one of the following conditions:
- 24 a. It has been authorized by a city, county, or more than one city or
25 county acting collectively to pursue an application and bid on the
26 applicant's behalf to a site selection organization for selection as the
27 site of a major event.
- 28 b. With the authorization of a city, county, or more than one city or
29 county acting collectively, it has executed an agreement with a site
30 selection organization regarding a bid to host a major event.
- 31 (4) Major event. – An entertainment, musical, political, sporting, or theatrical
32 event that satisfies the following conditions:
- 33 a. The event is either of the following:
- 34 1. Held at a sports facility.
- 35 2. Sponsored by the National Association for Stock Car Racing,
36 the Ladies Professional Golf Association, the Professional
37 Golfers' Association of America, the PGA Tour, or the United
38 States Golf Association.
- 39 b. The event is not held more often than annually.
- 40 c. The location of the event is determined by a site selection organization
41 through a competitive process.
- 42 d. The site selection organization considered multiple sites located
43 outside of the State for the event.
- 44 e. The site selection organization selected a site within this State as the
45 sole location for the event.
- 46 (5) Site selection organization. – The organization responsible for determining
47 the site of a major event.
- 48 (6) Sports facility. – As defined in G.S. 18C-901.

49 **"§ 143B-437.112. North Carolina Major Events, Games, and Attractions Fund.**

50 (a) There is established the North Carolina Major Events, Games, and Attractions Fund
51 to be administered by the Department. In order to foster job creation and investment in the

1 economy of this State, the Department may enter into multiparty agreements with site selection
2 organizations and local entities to provide grants in accordance with the provisions of this Part.
3 Before entering into an agreement, the Department must find that all of the following conditions
4 are met:

- 5 (1) The economic activity directly or indirectly attributable to the major event is
6 sufficient to justify the use of State funds to attract or retain the event in this
7 State.
- 8 (2) It is anticipated that the major event will provide positive media exposure for
9 the State, thereby supplementing the State's efforts to promote travel and
10 tourism within the State.
- 11 (3) The site selection organization must have considered multiple sites located
12 outside of the State for the event.
- 13 (4) The site selection organization has selected a site within this State as the sole
14 location for the event.
- 15 (5) The event is not held more often than annually.
- 16 (6) The project will benefit the people of this State by increasing opportunities for
17 employment and by strengthening this State's economy.
- 18 (7) The project is consistent with economic development goals for the State and
19 for the area where it will be located.
- 20 (8) A grant under this Part is necessary to attract or retain the major event within
21 this State.
- 22 (9) The total benefits of the major event to the State outweigh its costs and render
23 the grant appropriate for the major event.

24 (b) Effective July 1 of each calendar year, the funds remitted to the Fund by the Secretary
25 of Revenue from the tax on sports wagering pursuant to G.S. 105-113.128 are appropriated for
26 this purpose. In addition to the amounts remitted to the Fund pursuant to G.S. 105-113.128, the
27 General Assembly shall determine any additional amount appropriated to the Fund. Agreements
28 entered under this section are subject to appropriations.

1 (a) Tax. – A tax at the rate of eighteen percent (18%) is imposed on an interactive sports
2 wagering operator licensed under Article 9 of Chapter 18C of the General Statutes. The tax
3 applies to the gross wagering revenue of the interactive sports wagering operator.

4 (b) Carryforward. – If the amount of gross wagering revenue is a negative number for
5 any month, the interactive sports wagering operator may carry forward the negative amount to
6 the return filed for the subsequent month. No amount shall be carried forward more than 12
7 months after the month in which the amount carried forward was originally due.

8 (c) Return. – Taxes levied by this Article are due when a return is required to be filed.
9 The return is due on a monthly basis. A monthly return is due by the twentieth day of the month
10 following the calendar month covered by the return. A return is filed on a form prescribed by the
11 Secretary.

12 (d) Records. – A person who is required to file a return under this Article must keep a
13 record of all documents used to determine information the person provides in a return. These
14 records shall be open at all times for inspection by the Secretary or an authorized representative
15 of the Secretary and shall be kept for the applicable period of statute of limitations as set forth
16 under Article 9 of this Chapter.

17 (e) Refund. – An interactive sports wagering operator is allowed a refund of the tax paid
18 under this section on a sports wager that has been refunded. The Secretary shall prescribe the
19 manner in which an interactive sports wagering operator may request a refund under this
20 subsection, which may include allowing a credit for the amount refunded on a subsequent
21 monthly return required under this section.

22 **"§ 105-113.127. Bond or irrevocable letter of credit.**

23 The Secretary may require an interactive sports wagering operator to furnish a bond in an
24 amount that adequately protects the State from an interactive sports wagering operator's failure
25 to pay taxes due under this Article. A bond must be conditioned on compliance with this Article,
26 payable to the State, and in the form required by the Secretary. The amount of the bond is two
27 times the interactive sports wagering operator's expected monthly tax liability under this Article,
28 as determined by the Secretary, provided the amount of the bond may not be less than fifty
29 thousand dollars (\$50,000) and may not be more than two million dollars (\$2,000,000). The
30 Secretary should periodically review the sufficiency of bonds required of interactive sports
31 wagering operators and increase the amount of a required bond when the amount of the bond
32 furnished no longer covers the anticipated tax liability of the interactive sports wagering operator
33 and decrease the amount when the Secretary determines that a smaller bond amount will
34 adequately protect the State from loss.

35 For purposes of this section, an interactive sports wagering operator may substitute an
36 irrevocable letter of credit for the secured bond required by this section. The letter of credit must
37 be issued by a commercial bank acceptable to the Secretary and available to the State as a
38 beneficiary. The letter of credit must be in a form acceptable to the Secretary, conditioned upon
39 compliance with this Article, and in the amounts stipulated in this section.

40 **"§ 105-113.128. Use of tax proceeds.**

41 The Secretary shall distribute the taxes collected under this Article, less the allowance to the
42 Department of Revenue and reimbursement to the Lottery Commission for administrative
43 expenses, in accordance with this section. The Secretary may retain the cost of collection by the
44 Department, not to exceed five hundred thousand dollars (\$500,000) a year, as reimbursement to
45 the Department. The Lottery Commission shall, no later than 20 days after the end of the month,

- 28 (4) One million dollars (\$1,000,000) annually to the North Carolina Outdoor
29 Heritage Advisory Council for grants, in the discretion of the Council, as
30 follows:
- 31 a. Grants not to exceed five thousand dollars (\$5,000) per sports team per
32 county per year needing assistance to travel to in-State or out-of-state
33 sporting events and team activities.
- 34 b. Incentive grants not to exceed twenty-five thousand dollars (\$25,000)
35 to attract State, regional, and national sporting events, tournaments,
36 and programs for nonprofessional athletes participating in programs
37 administered by city, county, and local school administrative units.
- 38 (5) Of the remaining proceeds, as follows:
- 39 a. Twenty percent (20%) annually to be distributed equally among the

5 **SECTION 5.5.** Article 51A of Chapter 14 of the General Statutes is amended by
6 adding a new section to read:

7 **"§ 14-380.5. Horse racing not prohibited.**

8 Horse racing, as authorized and regulated in accordance with Article 10 of Chapter 18C of
9 the General Statutes, shall not be considered a horse show for purposes of this Article."

10 **SECTION 6.** If any section or provision of this act is declared unconstitutional or
11 invalid by the courts, it does not affect the validity of this act as a whole or any part other than
12 the part so declared to be unconstitutional or invalid.

13 **SECTION 7.** The Commission shall establish guidance to parties regulated by the
14 provisions of Articles 9 and 10 of Chapter 18C of the General Statutes, as enacted by this act.
15 Such guidance shall address the application of Article 9 of Chapter 18C of the General Statutes,
16 as enacted by this act, to electronic sports with due consideration to the key role of game

25 operations on January 8, 2024. If more than 12 completed applications are received, the
26 Commission shall select based upon the criteria set forth in G.S. 18C-904(f), as enacted by this
27 act, and notify the qualified applicants it determines will best serve the public interest in
28 maximizing revenue to the State, while preserving the integrity of sports wagering and ensuring
29 accountability and preserving the public trust in licensed sports wagering activities. No license
30 issued by the Commission shall become effective prior to January 8, 2024.

31 **SECTION 8.** The North Carolina State Lottery Commission shall use sufficient
32 funds from the North Carolina State Lottery Fund to cover initial operating expenses of the
33 Commission to implement Articles 9 and 10 of Chapter 18C of the General Statutes, as enacted
34 by this act, provided the total amount borrowed by the Commission shall not exceed fourteen
35 million dollars (\$14,000,000) without further action by the General Assembly. The Commission
36 shall repay any funds used out of the North Carolina State Lottery Fund pursuant to this section
37 within 36 months after the effective date of this act.

38 **SECTION 9.** The North Carolina State Lottery Commission shall study the

- 43 (1) Restrictions on number of licensees as established by G.S. 18C-904, as
44 enacted by this act, and how additional applications for licensure are treated.
- 45 (2) Any potential challenges to enforcement of the Articles.
- 46 (3) The establishment and use of the voluntary exclusion program.
- 47 (4) The siting and opening of public places of accommodation, and usage of such
48 sites.
- 49 (5) Any potential issues or challenges with audits of interactive sports wagering
50 operators and ADW licensees.
- 51 (6) Any other information the Commission deems relevant.

1 **SECTION 10.** Sections 1, 2, 3, 4, 5.5, and 6 of this act become effective January 8,
2 2024. Section 5 of this act becomes effective January 8, 2024, and applies to gross wagering
3 revenue received on or after that date. Except as otherwise provided, this act is effective when it
4 becomes law.
